Applications to vote by proxy at this election must reach the Electoral Registration Officer for your council area at Ashfield District Council, Urban Road, Kirkby in Ashfield, Nottingham, NG17 8DA or Broxtowe Borough Council, Foster Avenue, Beeston, Nottingham, NG9 1AB by 5 p.m. on Wednesday 31 May.
