The deposit for each candidate (£5,000) may be paid by cash or banker's draft (banks operating in the UK or Gibraltar only) made payable to "Rushcliffe Borough Council". Funds must be received by the closing date and time for nominations.

Applications to be included on the register of electors or for postal or proxy votes **MUST** reach the relevant Electoral Registration Officer for the applicant and not the address given above.
